Re: **THE WASHINGTON COURT OF APPEALS: FAIR AND EQUAL ELECTION RIGHTS
VIOLATED, AN OPPORTUNITY FOR JUDICIAL IMPROVEMENT**

Dear Representative Lantz and Senator Kline:

I write to you about the Washington Court of Appeals and the need to take action to correct some constitutional infirmities of the election of judges to the court under the fair and equal election requirements of the Washington Constitution.

I have enclosed a draft of an article I am working on, *The Washington Court of Appeals: Fair and Equal Election Rights Violated, An Opportunity for Judicial Improvement*. This article addresses the constitutional issues I refer to.

I also suggest the need to take action may present a legislative opportunity to significantly improve the court. In actual practice, the Washington Court of Appeals is “the supreme court” for the vast majority of cases appealed from our Superior Courts. Judges of the highest competence and character should be nominated and elected to the court. The Walsh Commission Report (WALSH REPORT – THE PEOPLE SHALL JUDGE (1996)) may be of interest in this regard.
